Participants in the Climbing Adventure should be prepared for moderate hiking with a moderate to heavy load followed by strenuous climbs. Anyone coming to our Cycling Adventure should be prepared for long rides over fairly moderate terrain. This adventure will include at least one multi-day trip.
