The most exciting part of the new Kodiak Challenge is the ability to plan and execute your own adventure. Monday will be spent developing the plan for your week here at camp. Whether your group wants to focus on one specific outdoor experience or would like to try a number of different options, we will help you make it happen!

As with all high adventure activities, participants should be prepared for an appropriate level of activity. It is suggested that Venturers and Advisors interested in attending Kodiak prepare themselves physically prior to camp. Because of the unique nature of planning for this event we can't say what you should prepare for specifically. A moderate level of outdoor proficiency including: paddle craft, camping, hiking, and mountain biking is suggested.
