- The application must include the completed form and <u>at least one letter of recommendation</u> from an individual unrelated to the Scout who is familiar with the Scout's leadership and accomplishments.
- The Scout may attach additional documentation or letters if desired.
- > The selection committee will consider all aspects of the youth's leadership and participation in Scouting, school, community activities, and faith practice.
- Finalists will be invited to participate in an interview.
- > The Judge John Price Eagle Scout of the Year award is presented at the annual council awards dinner.
- The accompanying \$1,000 college scholarship is paid directly to the institution in which the candidate enrolls.

The application may be submitted <u>either</u> in person, by mail, or by email. It must be *received* not later than January 21, 2024 to be considered.
